Extended Day offers full-time care for those attending Pre-K. The program consists of free choice play, structured activity, story time, snack, and quiet time. The children have the option of bringing lunch from home or signing up for hot lunch through the school. Extended Day is open for full-day use on Fridays. Students will be escorted to and from school by an employee at their given class time. Parents must enter the Extended Day building and sign their child in/out. Children are not released to people other than those on emergency card or previously arranged with the staff member.

Extended Day Program Hours

Open 7:00 a.m. M-F Close 6:00 p.m. M-F

EDP will be CLOSED school holidays, unless otherwise stated. We will be open for Teacher work days and Professional Educator Days.

Pre-K Extended Day Options/Rates

Full-time	\$350 per month (10 month contract Sept-June)
Part-time (any 2 consistent days)	\$190 per month (10 month contract Sept-June)
EDP Registration Fee	\$50

Pre-K Extended Day is by contract only, agreeing to pay the given rate for 10 months.

Extended Day Care (Pre-K 4) Contract

Tuition Contract 2017/2018 School Year

I understand that I am entering into a contractual agreement with St. Vincent de Paul School's extended day care and that I am obligated to pay my full extended day care tuition of **\$190.00 per month for 10 months(September/June)** for my child. I also understand that if I fail to pay my tuition and fees in full by the last day of the school year that I am responsible for all collection fees, attorney fees, and courts costs incurred by the school in order to collect the balance of my tuition amount. Charges will be deducted from your account on the **15th of the month**. We will use the same account information that you provided to us for your school tuition.

This is a Part-time Contract (MW or TTH) and I will commit to a consistent schedule.

Contractual Understanding

It is understood by the undersigned parent(s) and or guardian(s) that this is a legally binding agreement. Parents and or guardians consent to pay in a prompt timely manner. **It is understood that non-payment or late payment of tuition and fees will result in one or more of the following consequences:** (1) Up to a \$50.00 per month late fee. (2) Students dismissal from school. Again we agree to pay all penalty related costs and all collection expenses, attorney fees and court costs.
