



Extended Day Program 2018-2019

Extended Day is a safe, caring environment where the children can play, socialize, and complete homework. We provide an afternoon snack, outside play, homework time, art, and free choice activities. Because we are an extension of the school, we follow the Saint Vincent de Paul handbook and policies. Children are expected to uphold the same conduct and Christian behavior. If behavior is an ongoing problem, students may be asked to withdraw from Extended Day.

Parents must enter the Extended Day building and sign their child in/out. In the event that your child must leave Extended Day unaccompanied to a school activity, please send an email/note or give us a phone call. Children are not released to people other than those listed on their emergency contact information or previously arranged with the staff member.

Homework time is provided but the staff is not responsible for your child's completed homework. There is a computer available for "homework use" only.

Electronic devices from home are not allowed during the Extended Day hours.

EDP will be CLOSED on all school holidays for the 2018-2019 school year. We will be open on Teacher Work Days and Prof. Ed. Days.

Late Policy There will be a \$5 per minute charge up to 6:05p.m. and \$1 per minute thereafter. Also parents who are consistently late may be asked not to use the Extended Program.
