## 2019-2020 TUITION RATES

In the 2018-2019 academic school year, the Salt Lake City Diocese adopted a new tuition tier structure. The average cost of tuition in our diocese had not been calculated since 2008. After determining the average cost to educate a student, the diocese found that the Catholic rate was subsidized by the schools at approximately \$1,700 per student. To continue to ensure the financial health of our schools, the diocese decided that we must align our tuition with the cost of education.

We know that tuition is a major financial sacrifice for most of our Saint Vincent families. The school takes pride in its ability to provide tuition assistance for many of our families in need. Saint Vincent School will make every effort to meet the needs of families. No family will be asked to pay more than they can afford, as determined by their FACTS application. The FACTS application will determine a family's expected total contribution toward tuition. No family should leave our schools because of their inability to afford tuition for their children.

### Financial Aid Assistance

Need-based financial aid is available for students in kindergarten through 8<sup>th</sup> grade. Applications are available online at <https://online.factsmgt.com/signin/46BMX>. Completed financial assistance forms, a copy of your 2018 Federal tax return 1040 or 1040A, and any additional supporting documentation must be submitted to FACTS Grant and Aid Assessment (FGAA) by April 1, 2019. **APPLICATIONS FOR FINANCIAL ASSISTANCE MUST BE COMPLETED EACH AND EVERY YEAR.**

FGAA will review all applications. All requested information is kept confidential. All required information must accompany the form, or it will not be considered. The analysis and award process typically takes 2-3 weeks. Upon completion of the analysis, each family will be contacted by our school accountant.

The rates below reflect possible amounts that a family could qualify for based on their FACTS application:

Tier 1 - \$7763 – This amount reflects a rate a family will pay if they do not qualify for tuition assistance as determined by FACTS.

Tier 2 - \$6744

Tier 3 - \$5996

Tier 4 – Need-Based Aid: Rates vary depending on the need calculated by FACTS.

**PAYMENT SCHEDULE OPTIONS**

- Pay in full by July 20, 2019
- Pay 2 semiannual in July 2019 and January 2020
- Pay 4 quarterly payment: July 2019, October 2019, January 2020, and April 2020. You may elect to have your tuition withdrawn on either the 5<sup>th</sup> or the 20<sup>th</sup> of the month
- Pay 11 monthly payments, July 2019 through May 2020. You may elect to have your tuition withdrawn on either the 5<sup>th</sup> or the 20<sup>th</sup> of the month
- You may also select to pay bi-monthly, July 2019 – May 2020. These payments will be taken out on the 5<sup>th</sup> and the 20<sup>th</sup>
