2022-2023 ADMISSION RATES AND FEES

(New Applicants)

2022-2023 TUITION RATES

To continue to ensure the financial health of our schools, the diocese decided that we must align our tuition to the per pupil cost. Below are the proposed tuition rates for the 2022-2023 school year, which will be agreed upon and approved by the diocese within the month.

Proposed Tuition Rate.....	Grades K - 8th grade	\$8,319 + Fees (Non-Catholic) \$8,199 + Fees (Catholic)
Proposed Tuition Rate.....	Pre-Kindergarten 4-Year-Old	\$4,160 + Fees

FINANCIAL AID ASSISTANCE

We know that tuition is a major financial sacrifice for most of our Saint Vincent families. The school takes pride in its ability to provide tuition assistance for many of our families in need. Saint Vincent School will make every effort to meet the needs of families. No family will be asked to pay more than they can afford, as determined by their FACTS application. The FACTS application will determine a family's expected total contribution toward tuition. No family should leave our schools because of their inability to afford tuition for their children.

Need-based financial aid is available for students in kindergarten through 8th grade. Applications are available online at <https://online.factsmgt.com/signin/46BMX>. Financial assistance forms, a copy of your 2021 Federal tax return, 1040 or 1040A, and any additional supporting documentation must be started by February 17th, 2022 and submitted to FACTS Grant and Aid Assessment (FGAA) by April 25, 2022.

APPLICATIONS FOR FINANCIAL ASSISTANCE MUST BE COMPLETED EACH AND EVERY YEAR.

FGAA will review all applications. All requested information is kept confidential. All required information must accompany the form, or it will not be considered. The analysis and award process typically takes 2-3 weeks. Upon completion of the analysis, each family will be contacted by our school accountant. The rates below reflect possible amounts that a family could qualify for based on their FACTS application:

Tier 1 - \$8,319 – This amount reflects a rate a family will pay if they do not qualify for tuition assistance as determined by FACTS.

Tier 2 - \$ 8,199

Tier 3 – Need-Based Aid: Rates vary depending on the need calculated by FACTS.

REGISTRATION FEE: (Existing Families PreK 4-8 th , due January 14, 2022)	Pre-K – 8 th grade per child	\$60
*GENERAL FEE:	K - 8 TH grade per child	\$335
*GENERAL FEE: Fees include student insurance, Diocesan fees, textbooks, standardized tests, technology fee, workbooks, and yearbook	PreK-4 per child	\$170
*MATH FEE	6 th – 8 th grade per child	\$175
*GRADUATION FEE:	8th grade only	\$100
*CHROMEBOOK LICENSE FEE: (Incoming 6 th grade and new 7 th & 8 th grade students)	6 th -8 th grade per child	\$40

PAYMENT SCHEDULE OPTIONS

- Pay in full by August 5, 2022.
- Pay 2 semiannual in July 2022 and January 2023.
- Pay 4 quarterly payments: July 2022, October 2022, January 2023, and April 2023. You may elect to have your tuition withdrawn on either the 5th or the 20th of the month.
- Pay 11 monthly payments, July 2023 through May 2023. You may elect to have your tuition withdrawn on either the 5th or the 20th of the month.
- You may also select to pay bi-monthly, July 2022 – May 2023. These payments will be withdrawn on the 5th and the 20th of the month.
